**IN THE MATTER OF AMENDING SECTION 3 OF RESOLUTION NO. 7804
AND ANNEX "A" THEREOF**
Promulgated: 18 January 2007

RESOLUTION NO. 7804-A

This is to amend Section 3 of Resolution No. 7804 which reads:

"SEC. 3. Where to file manifestation of intent to participate. – The manifestation of intent to participate by any of the abovementioned organized groups shall be filed with the Clerk of the Commission, Commission on Elections, Manila, in twelve (12) legible copies.

Additional thirteen (13) copies shall be filed by a political party with a national constituency.

The manifestations must be signed by their President or Secretary-General.

Manifestations filed by mail, telegram or facsimile shall not be accepted.

SEC. 3. Where to file manifestation of intent to participate. - The manifestation of intent to participate by any of the abovementioned organized groups shall be filed with the Clerk of the Commission, Commission on Elections, Manila, in twelve (12) legible copies.

The manifestations must be signed by their President or Secretary-General.

Manifestations filed by mail, telegram or facsimile shall not be accepted.
